# "Should the Community Buy CalAm?"

unch & Learn with the League this month will host a forum of speakers in favor of a public agency buying out the California American Water service.

A new coalition of business and other interests has formed, called **WaterPlus**. It is proposing the reorganization of the **Monterey Peninsula Water Management District** under state law in order to set in motion the buy-out effort.

Long-time water activist and LWVMP Natural Resources Committee Director **George Riley** will moderate the forum, allowing about 15 minutes for each speaker, with audience Question and Answer session at the end.

Adam Scow will give an overview of other efforts

in California. **Barbara Sprenger** will review the successful experience in Felton. **Ron Weitzman** will present the activities of WaterPlus.

Adam Scow is the California Campaigns Director at **Food & Water Watch**, developing strategy for local, state, and national campaigns. He currently serves on the planning committee for the annual California Water Policy Conference, sponsored by Public Officials for Water and Environment Reform. Previously, Adam researched California irrigation subsidies and water transfers in Washington DC.

Barbara Sprenger, CEO of **Satellite Telework Centers**, was a leader in **Felton FLOW's** (Friends of Locally Owned Water) six-year effort to gain public ownership of Felton's water system from CalAm. Barbara, a long-time local activist in social



#### **Program Planning Meeting Update**

On January 26 we agreed on the following as LWVMP suggestions to the state League for its 2011-13 program: (1) survey the local state Leagues for their views of the California budget priorities; (2) keep advocating for single payer health insurance; (3) continue to advocate on climate change issues based on League positions; and (4) continue to monitor events regarding state water projects.

We also proposed topics for advocacy and education for the 2011-12 program: (1) evaluation of privatization of local water distribution based on present positions; (2) continue to follow the development of local water supplies; (3) concentrate on recruitment of new League members; and (4) take an in-depth look at local K-12 education. No new study was put forward. The local program will be voted on at the May annual meeting.
